Click the orange button with the white arrow to toggle the control panel between hidden and displayed

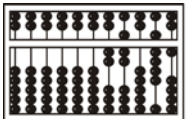
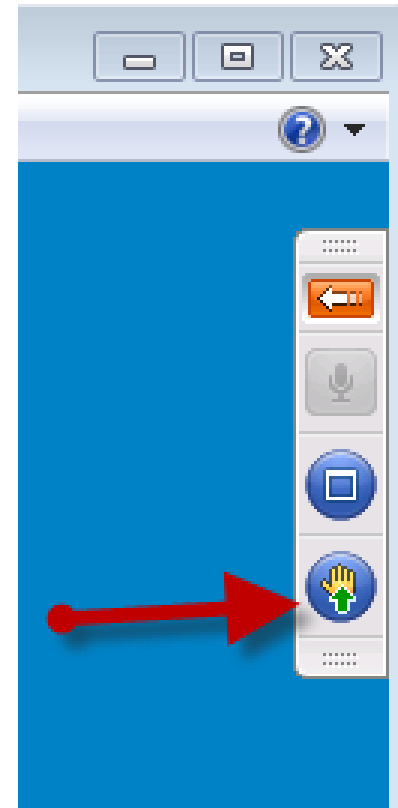

Background

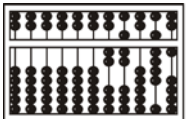
- ▶ We currently provide software to your County to manage the various processes related to the CPSE process. Many of these are centered around fiscal concerns including paying providers and billing Medicaid
- ▶ SED and DOH are continually adding more rules and regulations making this process more difficult.
- ▶ In order to address changes and streamline their operations, the County is deciding to utilize a module of ours named CPSE Portal.
- ▶ Providers will use CPSE Portal to submit attendance and billing to the County electronically
- ▶ There is no charge to the providers to use CPSE Portal

Who we are

- ▶ James McGuinness and Associates

What is CPSE Portal

- ▶ A web based portal that provides a mechanism for exchanging data between the County and providers (<https://www.CPSEPortal.com>)
- ▶ Provides for collecting attendance and billing information
- ▶ Captures digital signatures
- ▶ Provides electronic billing services
- ▶ Also supports Medicaid related information
- ▶ Linked to County Preschool data management system

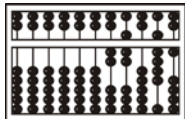

CPSE Portal is not CLAIMS/Enter Claims

- ▶ We market a product to agencies named CLAIMS
- ▶ There is a module for CLAIMS called Enter CLAIMS that captures attendance from therapists via a web browser
- ▶ CPSE Portal is an entirely different system
- ▶ CPSE Portal is a web based interface to link to the County's Preschool software system
- ▶ There is no charge to providers to use CPSE Portal

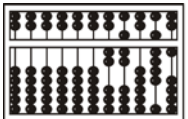

How does data get into CPSE Portal

- ▶ Users can data enter into website.
- ▶ Agencies that use CLAIMS / EnterCLAIMS can upload data in a file to CPSEPortal
- ▶ Agencies that use any other software package can also upload attendance data from their systems. File specifications are available in the knowledge base.

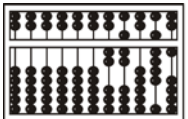

Process overview

- ▶ Providers either
 - ▶ Enter attendance information for enrollments
 - ▶ And provide a digital signature to the attendanceor
 - ▶ Upload digitally signed attendances from their own electronic attendance/notes system
- ▶ Billing Provider creates an electronic voucher from these attendance entries
- ▶ Billing Provider then
 - ▶ digitally signs and submits electronic voucher to County
 - ▶ prints voucher summary sheets from CPSE Portal
 - ▶ submits paper voucher sheets to County (US mail, drop off, etc.)
- ▶ County user reviews, audits, processes and posts voucher to Preschool system



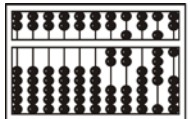

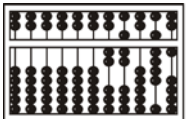

Billing Provider vs. Service Provider

- ▶ A Billing Provider (think Agency or School)
 - ▶ Can be an individual or corporation
 - ▶ Has a vendor contract with the County
 - ▶ Submits bills to County
 - ▶ Receives payment from County
- ▶ A Service Provider (think therapist)
 - ▶ Is an individual
 - ▶ Provides the services to the child
- ▶ An Independent Provider can be both a Billing Provider and Service Provider
- ▶ An Independent Provider can be incorporated and the Billing Provider is the corporate entity and the Service Provider is the individual person

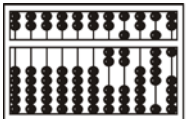

When will we start using CPSE Portal

- ▶ Attendance and Billing
 - ▶ For Center Based (tuition), SEIT/SEIS and Related services,
 - ▶ Service dates beginning 7/1/16
 - ▶ Evals
 - ▶ Service dates beginning 9/1/16

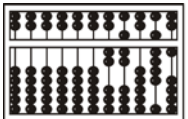

Timing

- ▶ April
 - ▶ Establish Agency admin user logon
 - ▶ Plan additional office staff users
 - ▶ Gather therapist/teacher information (Name, email, etc)
 - ▶ Training for Setup processes
 - ▶ For agencies looking to upload attendance from their own system, begin the process to create the upload file
- ▶ May
 - ▶ Setup users for Agency
 - ▶ Initial training webinars
- ▶ June
 - ▶ Training
 - ▶ Caseload maintenance / setup
- ▶ July
 - ▶ Enter Attendance
 - ▶ Billing Training
- ▶ August
 - ▶ Create and submit electronic bills

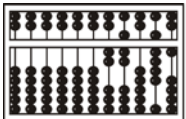

Billing Provider Account

- ▶ Initially, each contracted provider will be set up with Billing Provider admin Account to login to CPSE Portal
- ▶ This admin account is used to register other users that can access CPSE Portal under their provider. The system sends an electronic invitation to enroll.
- ▶ Types of provider users
 - ▶ Billing Provider
 - ▶ Basic
 - ▶ Admin
 - ▶ Service Provider (therapist, teacher, etc.)
 - ▶ Supervisor
- ▶ Independent providers will have their account marked as both a Billing Provider Administrator as well as a Service Provider

Next steps

- ▶ Provider Setup Forms
 - ▶ NPI
 - ▶ Initial Admin User
- ▶ Prepare List of Administrative office users
 - ▶ Name, email
- ▶ Prepare List of Service Providers (teachers, therapists, etc.)
 - ▶ First name, last name, email, profession, NPI, NY License, Is Supervisor

- ▶ Decide if you will be uploading data or data entering
- ▶ If uploading data, contact your IT Vendor about uploading data



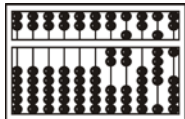

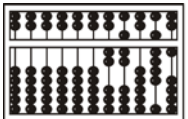
- ▶ In addition to creating individual invites, you can upload a spreadsheet with the following format, which can be downloaded from the knowledgebase.

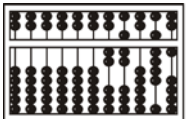

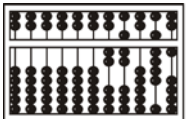
